## UAE Veterinary Registration Form

- All Veterinary services are online; the required supporting documents must be uploaded with the online application. Original passport should be sent to Federation for authentication
- All horses undergoing registration – FEI & NF- must be microchipped and the microchip number mentioned in the application
- If the horse is below 4 years and born in the UAE, passport copies of both the sire and the dam must be submitted with the application form
- To fill in the "Markings & Description Page", and the "Equine Influenza Vaccination" details, contact a veterinarian approved by the UAE Equestrian and Racing Federation

### Acceptable Identity documents:

- Proof of Ownership:
- Transfer of Ownership form mutually signed by the Current and new owner
- Agreement/ sale deed/
- Import Health documents/Shipping Agents' letter substantiating the ownership of the horse, in case of imported horses
- Breed Registration Certificate
- Previous Identity documents, if any, registered with any other National Federation

On receipt of the application, the passport will be issued within two working days, barring any unforeseen delays or complications.
