





BIOSECURITY PROCEDURES FOR FEI ENDURANCE WORLD CHAMPIONSHIP OUARANTINE FACILITY

- 1. Only accredited personnel and FEI officials visiting BIEV Quarantine stable will be allowed access to the quarantine facility. No children under 12 years old.
- 2. No animals, other than quarantine horses, may be brought into the facility.
- 3. No media, with exception of nominated official media (private photography of own horses and personnel allowed).
- 4. Only registered team personnel permitted during stable open hours (one groom ,team vet, chef d'equipe). The BIEV quarantines reserves the right to refuse admission or expel any person from the premises.
- 5. Only registered team personnel will be permitted access to horses in quarantine for the first 48 hours after arrival.
- 6. At every visit, all visitors must wear the protective clothing provided. Hands must be sanitized on entering the barn and again before exiting. The visitor's record forms must be signed and completed.
- 7. Only official certified vehicles allowed in quarantine area.
- 8. Only medications and treatments issued and/or approved by quarantine veterinarians are permitted. Only approved vets and therapists are allowed to treat horses.
- 9. Vector screens must be closed at all times and only opened for the entry/exit of horses.
- 10. Horses and personnel must enter and leave the Quarantine facilities through approved gateways.
- 11. Any suspected contagious or infectious disease of people or horses must be reported immediately to quarantine management.
- 12. No alcohol is permitted in the barns or public areas. No smoking is permitted in the barns.
- 13. All persons attending horses in the facility are subject to the Rules and Regulations of the UAE and FEI
- 14. Horse temperature must be recorded twice daily in both the FEI HorseApp and quarantine records







Exercise of horse in Quarantine

Exercise of horses within Quarantine is permitted under the following conditions;

- It is the trainers/representative's responsibility to ensure all horses exercising outside the barns are wiped down with the insect repellent provided in each barn prior to exiting the barns. Where required, the daily treatment must be recorded and signed.
- During exercise periods instructions from track stewards must be obeyed and a minimum 50
 meters separation maintained between groups of horses. Failure to do so may result in a
 revision of export requirements and an extended quarantine period.
- Helmets to be worn at all times when mounted outside the Quarantine
- Horses have been within quarantine for at least 48 hours and all required samples have been taken.
- There are not believed to be any infectious or contagious diseases within the group including but not limited to Ringworm
- Any clinical signs noted during exercise must be reported to the relevant Quarantine Manager of the facility upon cessation of exercise
- Exercise only takes place during permitted training hours and is at the discretion of the quarantine stewards.
- All tack and equipment required for exercise is delivered to the respective quarantine prior to commencement of riding for checking and disinfection
- All tack and equipment must remain at quarantine for the duration of the quarantine period
- All quarantine biosecurity procedures are adhered to and riders and their clothes have not been in contact with horses outside of the quarantine on the day of exercise
